A RESOLUTION OF CITY OF DELTONA, FLORIDA, APPROVING THE COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION PLAN FOR PROGRAM YEAR 2022-2023; AUTHORIZING THE CITY MANAGER TO EXECUTE THE REQUIRED FEDERAL FORMS AND CERTIFICATIONS; AUTHORIZING SUBMITTAL OF THE PLAN; AUTHORIZING THE ADMINISTRATION OF THE PLAN; PROVIDING FOR CONDITIONS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Deltona, Florida is a Community Development Block Grant entitlement community; and

WHEREAS, the City Commission of the City of Deltona desires to obtain federal Community Development Block Grant funds and administer Community Development Block Grant programs; and

WHEREAS, the United States Department of Housing and Urban Development requires all entitlement communities submit an Annual Action Plan to adhere to the requirements of applicable federal regulations; and

WHEREAS, the City of Deltona has prepared a Community Development Block Grant Annual Action Plan that includes the federal application for funds and all required forms and certifications to apply for funds from the federal Community Development Block Grant program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DELTONA, FLORIDA:

Section 1. The City of Deltona Community Development Block Grant Annual Action Plan for Program Year 2022-2023, attached hereto is hereby approved.

Section 2. The Acting City Manager is hereby authorized to submit the Community Development Block Grant Annual Action Plan for Program Year 2022-2023 as a request and approval for funding from the United States Department of Housing and Urban Development.

Section 3. The Acting City Manager or designee is hereby authorized to administer the Community Development Block Grant program; the Consolidated Plan, Strategic Plan, Annual Action Plan and Citizen Participation Program.

Section 4. Conflicts. All Resolutions or parts of Resolution insofar as they are inconsistent or in conflict with the provisions of this Resolution are hereby repealed to the extent of any conflict.

Section 5. Severability. In the event any portion of this Resolution is determined to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such decision shall in no manner affect the remaining portion or sections of the Resolution which shall remain in full force and effect.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption by the City Commission.
