4	<b>ELECTRICAL</b> Hot Check - all accessible outlets. Includes written inspection report from Electrician. GFCI's (6) per scope of work. Replace garage ceiling light. Replace exterior light at sliding glass door. Install new lithium battery smoke (2) and combo units (2). Loose outlets and exposed electrical wires will be reviewed at Hot Check. *** Repaired items noted on Hot Check to be priced and added as change order. ***	
5	<b>GENERAL CONDITIONS</b> Permits, insurances, disposal, project management, mobilization, and final cleaning.	Included above
	*** Any painting, drywall, stucco or siding repairs will be extra to the contract unless listed above. ***
