BACKGROUND:

The Acting City Manager is proposing a millage rate of 7.8500 mills, a millage rate that is unchanged from the rate levied in FY 2020/2021 budget and reflects an increase of ______% from the rolled-back rate of ______mills. Staff proposes that the Commission adopt a tentative proposed millage rate of 7.8500 mills for FY 2021/2022. At the time of this writing, the City is waiting for the Volusia County Property Appraiser to publish the taxable values and rollback rate on July 1, 2021. Attached is Resolution No. 2021-33 establishing a tentative proposed millage rate. The adopted rate will be communicated to the Property Appraiser and used in the Notice of Proposed Property Taxes (TRIM Notices) issued to Deltona property owners in late August.

Upon approval of this item authorizes any and all necessary actions, documents or budget transfers to facilitate Commission approval and further authorizes the Acting City Manager to sign any documents necessary to further Commission approval of this item.
