SUBJECT: SD22-0017 – Replat of Halifax Crossing application to replat 14 parcels into seven (7)

new parcels with two tracts for future development and stormwater.

Applicant: Delana Johnson, Allen & Company

**REFERENCES:** Halifax Crossings Development Order, City Comprehensive Plan, Code of Ordinances Section 106-30 and 106-31, Halifax Crossings MPUD Development Agreement.

**REQUEST:** The applicant is requesting a Final Plat for Halifax Crossings. This will legally subdivide the existing parcels into seven (7) lots and two (2) tracts for future development and stormwater. The subdivision of the land is subject to the codes outlined in the Reference section above.

**DISCUSSION:** The applicant submitted the Final Plat application on December 20, 2022, proposing to replat 14 parcels into seven (7) new parcels and two tracts, covering approximately 109.71 acres along Halifax Crossings Boulevard. The property is currently zoned MPUD.

Following the review of the application and supporting documents submitted on December 20, 2022, with additional documents being submitted on February 23, 2023, the application was deemed sufficient on March 15, 2023, and the first DRC Comment Letter was issued on April 27, 2023. The application underwent eight (8) review cycles, with the final submittal received on September 9, 2025. Staff has determined that all substantive issues have now been resolved.

**ANALYSIS:** The Final Plat has been reviewed by both the City's Surveyor Consultant and the City Attorney, who have confirmed that the plat and associated documents are sufficient for approval.

### STAFF RECOMMENDATION:

The proposed Final Plat complies with all relevant provisions of the City's Comprehensive Plan and Land Development Code Section 106-31. Staff recommends that the Development Review Committee approve the Final Plat application SD24-0015, subject to the following conditions:

- 1. The Final Plat Development Order must be recorded in the public records at the same time as the Final Plat mylar by the applicant.
- 2. The applicant must reimburse the City for the costs of legal review before the plat is recorded.
