Member Borgens mentioned the fire department wants to get accredited.

Fire Marshal Shivers spoke regarding the accreditation align with the Codes to be enforced. She also mentioned it needs to be cleaned up.

Member Borgens requested to remove the language from the Fire Code, and clean up to follow the Florida Statute.
