Daytona Beach	- None - Mobile food vending shall not be allowed to operate on any single property for more than eight hours in a 24 hour period.	N/A	N/A
Daytona Beach Shore	- No more than one (1) mobile food vehicle shall operate on any property at any one (1) time, except as may be authorized by a special event permit or development agreement approved by the City Commission	N/A	Not permitted
Debary	-No single parcel may host more than one mobile food dispensing vehicle for more than one day per calendar week. - A mobile food dispensing vehicle may not be located on the same parcel of real property for more than 12 hours in a single calendar week.	N/A	N/A

Holly Hill	- A site may not host a mobile food vehicle for more than four hours on any permitted calendar date except when a special event permit has been issued for the site that provides different hours of operations. - Mobile food vehicle rally is where two or more vehicles congregate to offer food or beverages for sale to the public, functioning as a single business and may provide restrooms, tables, play areas, a structure for alcohol sales, and other outdoor entertainment open to the customers of all vendors. These events must receive a special event permit, or they can be approved part of a city sponsored event.	N/A	Not permitted

Orange City	- Any one particular food truck may operate from the same property for up to eight days per calendar month. - No more than two food trucks may operate on the same property at the same time.	N/A	N/A
Ormond Beach	- Permitted as part of special event or mobile food dispensing vehicle host permit - More than one - does not specify limit	N/A	Not permitted
Ponce Inlet	- A maximum of three mobile food vendors may be permitted per host property at any given time. - A single mobile food vendor operating within a host property may occupy up two of the required parking spaces of the existing principal use. - Additional mobile vendors may be allowed to operate on the same host property if more than the minimum required number of parking spaces are available. - An approved mobile food vending site for an active mobile food vendor permit shall not be used by any other mobile food vendor for any duration of time between the issued date and expiration date of the permit. Volusia County	- No limit, however shall not impact required buffers, required parking, drive aisle and any ADA accessible pedestrian access, emergency access, loading zones, or otherwise impede traffic patterns or ingress and egress to buildings and businesses.	- A mobile food dispensing vehicle shall not provide any permanent outdoor dining areas but may use existing outdoor dining or other permanent seating authorized for an existing business on site with the business owner's permission.
