

MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (this "Memorandum") is made by Sold, LLC, a Florida limited liability company, ("Landlord"), whose address is 809 E. Yorkshire Drive, DeLand, FL 32724 and CLEAR CHANNEL OUTDOOR, LLC, a Delaware limited liability company ("Tenant"), whose address is 5333 Old Winter Garden Road, Orlando, FL 32811 upon the following terms

Landlord is the owner of the following described Property

Tract A of REPLAT OF DELTONA LAKES UNIT TWENTY-NINE AND THIRTY-SEVEN, a Subdivision according to the Plat thereof, recorded in Plat Book 27, Page 181 - 183, of the Public Records of Volusia County, Florida.

- 2. Landlord and Tenant have entered into that certain Lease# 70 433, dated Solember 14, 2023 (the "Lease"), wherein Tenant has leased portion(s) of the Property for the construction, maintenance and operation of one or more outdoor advertising structures for a term beginning __/_/2023, and continuing for the term of twenty (20) years, excluding extensions and renewals, if any.
