## A. AHAC minutes of May 20, 2025.

## A. Continued Discussion on the Community Land Trust (CLT) model.

Mr. Grose advised the Committee that Resolution No. 2025-68, establishing a Community Land Trust (CLT) to be managed by a Community Land Trust organization, was passed by the City Commission at the July 7, 2025, Commission Meeting.

Mr. Grose said the next step would be to reach out to CLTs, draft an agreement, and obtain Commission approval. This is expected to occur during the September/October time frame.

# B. <u>Discussion on the updated Local Housing Assistance Plan (LHAP).</u>

Mr. Grose stated the Local Housing Assistance Plan (LHAP) is updated every three years (triennial) and will go before the City Commission for approval at the July 21, 2025, City Commission meeting.

Staff incorporated changes into the LHAP.

Discussion ensued as how to inform Deltona residents about the programs.
